What Happened to Normal Behavior?

The other day I was talking with a National Alliance member and he was a bit annoyed at how strange and odd so many people behave these days. I certainly know what he's talking about, and actually most people, even people who are not so bright. know that the social norms in our society today are so far gone, that we have lost sight of what our norms once were. This is almost entirely because of the Jews. Let me explain.



What is considered normal behavior differs by race.

When the Jews really started to flex their muscle, that is, when they had gained enough control of the European banks, enough influence within White national governments, and a majority control over the media outlets, they launched themselves into deliberately attacking White social norms.

Now, let me first say, that I know there are Jews who are so filled with hate that they consciously do harm towards Whites and other races with deliberate malicious intention. But, the whole overall behavior of Jews stems from a genetic behavioral trait. Jews have evolved, in the pawn shops, loan offices, and used car lots of Europe and the Middle East. Now, they didn't have used car lots 2,000 years ago, but there were equivalent, sleazy, morally depraved businesses back then in which Jews thrived. One such institution that Jews have long excelled in is the sex-slave business.

From the beginning of time, up to about 200 vears ago, slavery was the universal norm around the world. With the White race in its peak, in advancements of science, industry and a growing, complex development in social studies, such as history, the leaders in Europe came to the firm understanding of the dynamics of race. They realized that dominant race conquers weaker ones, enslaves them, and mixes with them. This results in a mongrel race which causes the civilization to collapse, because the genetic quality of the original dominant race was lowered via race-mixing. With that knowledge, at the time, a social revolution was started so as to do away with slavery, as a needed change to preserve the White race. Hence slavery was abolished by Whites, because that was in the best interests of Whites. In the ancient world, Jews

thrived in such widespread industries as loan sharking, and sex slaves, and still do so today. This is just a genetic trait. What is a genetic behavioral trait?

As a molecular biologist, I am tempted to launch into a detailed scientific explanation, but, simply put, we all have a comfort level in our bodies. The human body creates a basal level of endorphins that create a calm stasis within us. When we are in an unnatu-

ral, harmful situation, we feel stress or anger or fear. When we are doing something right, we feel good about ourselves. This is our genetic heritage from our ancestors, the way we are made up physiologically, that which sets the pattern for our behavior. There are many scientific studies currently taking place on the subject of the endocrine system and the hypothalamus, so we should see some fairly exciting scientific breakthroughs in our lifetime, which will explain the cause and effect of our emotions and physical health.

But, what is for certain, is that our emotional and physical health are completely integrated into one another; that they are basically one in the same. People really can die from a broken heart. Enough harmful emotions can kill a person. Stress, and the health disabilities associated with stress, is caused by what people do and fail to do. Our brains process the information from the world around us, and if events are going well, then we feel good. When situations are going great, we feel great, sometimes even euphoric. But, harmful matters which occur around us trigger a negative emotion. And, the way that our bodies respond to these events are very different in different races.

For example, when White people see a baby harmed, even if it is not their own baby, the immediate reaction is fear and disgust, with the desire to help the baby. Within the Asian world, the Oriental race, that is the Mongoloids, it is considered rude to interfere in such matters. They have gone so far as to coin phrases that in essence tell their society to not concern themselves with other people's children. Just 50 years ago, the Chinese people, in bad times, would feed their newborn baby to their pigs. This act must seem unreal to the average American

today, but the Chinese brain is different than ours. They look at the pig as being a part of wealth and an unwanted baby as a burden. The White race just can't do such a thing. We are biologically different. Within the White race, harming a baby is such an abhorrent occurrence, that even when there were, in ancient times, Eugenic practices which called for grossly deformed or severely retarded babies to be aborted (such as, for example, happened in Ancient Sparta), these laws had to be codified into religious laws, and certain people with the suitable temperament were picked from society and trained to do those things. Even then, it was a terrible job.

In Ancient Greece, in the city-state of Sparta, newborn children were examined by religious leaders to bless the newborn, but also to inspect the child for deformities. They knew they had to act fast, before the mother fully bonded with the baby. If, for example, the newborn was missing a leg at birth, then the practice was to euthanize the child. The word "euthanasia" is a Greek word that means "good death." It was believed in the ancient world that life is sacred and a life of pain and suffering was a bad life, and was against the force of life. They believed that a painful life was upsetting and actually against the sanctity of life. A person with a pain-filled life is always a burden on their loved ones and thus spreads the pain out onto the group. So, in the ancient world, the moral choice was to "euthanize" a malformed child. It is an interesting fact that Sparta never built walls for its city. Actually, it never was anywhere near as impressive as Athens. Today, the location of most of Sparta isn't much defined. The general location is known and I've been there myself. It is now a growing suburb outside of Athens that still processes a rural charm. But, there are no impressive ancient buildings, such as the Parthenon. However, the one place of ancient Sparta that is positively located, which you can hike up the hills and visit, is the large, deep hole in the mountain into which the deformed babies were thrown. This was a very sacred place in ancient times. It was forbidden to go to this place, except for when it was being used. Contrast that with the Chinese feeding their healthy babies to their prized pigs. This is a huge difference and it is racially derived. In fact, most every action that we take is racially derived.

Let's look at another example. Take the institution of marital fidelity. In Black Africa, that is in the Negro portion which has not been converted to Islam by the Arabs, there is no concept for 'staying faithful' in the Negro languages. When Stanley and Livingston first explored darkest Africa, the Negroes didn't even understand the concept. To

Negroes, the husbands and wives had sex, but when they were away, they had sex with whomever. To the Negro brain, anything else was absurd. And the parental instincts of the Negro father are also so much different than Whites. This has nothing to do with Negroes living in primitive conditions in Africa. When Negroes live in America or Sweden, they don't think or behave any differently. Contrast this with the White race that has, since the dawn of time, written poems about being chaste with the one they wed. White people have declared wars over such a transgression. In more obsessive times, White people actually invented the chastity belt, to physically ensure the physical commitments of marriage remained certain.

All these differences are just a difference in race. This, of course, is the belief of the National Alliance and part of our ideology. Yet, the dominant ideology in our society is the Jewish/Liberal concept that environment matters for everything, and biology doesn't play a part. On occasion, this Jewish ideology will concede that a small percentage of intelligence is genetic. The whole idea is really absurd when you think about it.

Why are apes less intelligent than humans? Because of the genetic material we are made up with. You cannot put an ape into a Harvard classroom and make it more intelligent. The DNA that the ape is made up from determines its intelligence. Everyone understands this, but here is where it gets a little more technical.

Everyone also realizes that there are smart people and dumb people, but the Jews and Liberals created the concept of "nature versus nurture," which is basically pseudo-social science created to support the liberal political dogma and, ultimately, the Jewish agenda.

According to the untruthful "nurture, not nature" ideology, all humans have the same intelligence, and there are no real instincts or genetically set behavior traits. While we are growing up, everything that happens to us is supposedly a major influence on our intelligence and behavior. Yet, people can see that hair and eye color, as well as the shape of a persons face and even their height, has a direct correlation to that person's parents. Everyone knows that children will look like their parents because of the DNA which was passed on to them. This is accepted, but intelligence and behavior, as claimed by the Jews and Liberals, is purely or mostly environmental, hence we are all equal.

The subject of intelligence has been so thoroughly proven to be genetic, just as athletic ability and physical appearance, yet this proof is by and large marginalized by Jewish and Liberal rhetoric and outright lies, to the point that it is rarely talked about. In fact, the reality that behavior itself is genetic is ignored.

Actually, even within the White racial movement in America, the topic is minimized to the point where most people just say that: "It's their nature." This in itself is correct, but doesn't shed much light on the matter.

If we look at the way behavior works in the human body from a physiological approach, we see that the human brain reacts to outside stimuli and quickly processes the information and sends signals through the body via hormones. The very rapid speed of the hormonal release is amazing when one looks at all the various steps in the hormonal cascade. But so far, there isn't much evidence that the pathways have any difference between the races. Even the mechanics within the endocrine system don't share any measurable difference. There is a slight difference between Negroes and Whites with the neural-muscularjunction. Here, there is a higher volume of acetylcholine receptors in the neural-muscular-junction with Negroes. This gives Negroes a slightly faster "twitch" to the speed of the muscle response. But, the speed of the signal sent from the brain is virtually identical. So, most evidence in this regard shows that the behavior traits lay further upstream in the system; in the brain itself. So, how is it that different brains can process information from the same stimulus and produce a different outcome?

This is called divergent evolutionary pathways. This isn't a matter of one race being 'superior' than another race. Sure, Whites are much more successful in White countries than Blacks are, but put Whites in Black societies and the Blacks thrive in their lands and Whites suffer. We are just different and it cannot be changed. And it isn't a matter of one race being older or younger than the other. Think about it, no matter when the races branched off, from that point on, the exact amount of time has elapsed for all the races. They just went in different directions in so many ways. None are right or wrong. It is the same as comparing a lion to a tiger; they are just different.

But these differences are real and have a great deal of impact on all societies. Let's take for example a feeling that I'm sure every red-blooded White man has felt. I don't know the correct term for this physiological response, perhaps there hasn't been a name properly assigned to it, but it is as real as love and hate.

When I was in the Marine Corps, some older Marines had some very racist terms and phrases.

The one phrase that was used in the battalion I was in to describe the physical sensation that White men feel when the see a White women with a Black man, that unique disgusted feeling, was called "the rush of disgust." It is a real sensation. There is an environmental stimulus that instantly triggers a hormonal response and immediately the person feels very disgusted, as if bile just built up in their gut. It is a very natural, highly-evolved sensation that is necessary for the preservation of the White race. Without this protective mechanism, the White race would have gone extinct long ago. This is a natural territorial defensive mechanism, but the territorial nature in this case is not real estate, but rather our biological other half. Without ever being told by anyone, in fact, despite 50 years of the Jews trying to brainwash our entire race, the fact remains that the majority of White men all over the world absolutely hate it when they see White women and Black men together. In fact, even many Arab men, Latino men and Asians men also find that visual stimulus as unpleasant. The only race that appears to like this union is the Jewish race, which biologically speaking, isn't very different from Arabs. But Jews, with their enormous, yet often reserved hatred of the White race, see past the disgusting nature of such a union and instinctively know that this harms the White race, and this makes them happy.

So, this leads me up to the topic of today's show: "What happened to normal behavior?"

Well, the Jews control the media and know that the human brain is highly susceptible to obeying leadership and fashion trends. The Jewish agenda is such that they want societies weakened, so as to make them so much easier to control. The Jews would not be able to introduce even one percent of the harmful, degeneracy of today's trends, just 100 years ago. They would have been lynched in public and most law enforcement agents would have accepted such a lynching as good behavior on the part of the citizenry and allowed it to go unpunished.

But, just as military "boot camp" is designed to break down a civilian person in order to create a military person, the Jews have used their social Trojan horse of *Liberalism* to break down White America and to tear apart the social fabric of normal behavior within our society. This trend isn't new either.

By the 1930s, the term "a conformist" in academia, was becoming a strong insult. Instead of having a normal, healthy society with proper standards for behavior, the Jews pushed for a strange individualism. They pushed the idea that it's OK to

be different, even to be very, very different. This anti-normal behavior propaganda taught White people to not enforce normal, healthy standards. Instead, they introduced drugs to poison the body and brains of America's youth. To complain about such things made you a geek and old-fashioned. The Jews glorified irresponsible actions and lifestyles. In the 1960s, it was with the "Flower Children." Today it is with White girls having sex with Negro rappers. To attack the normal, healthy response to such naturally disgusting social circumstances, the Jews created a powerful taboo against the very needed defense mechanism that would save us: White racial pride.

Any White country that has a strong sense in racial pride would be able to see the difference between what is good and what is bad for a society. To push homosexuality onto high school children or to allow the movie industries to make films that glorify the drug culture would never be allowed in a healthy White society.

It wasn't too long ago that White America still had a sense of some social norms. In the 1970s, when a hippy guy had a long pony tail, there was a common phrase used by millions of people to show their disapproval. They would just loudly say, so everyone in the room could hear, "Is that a man or woman?" This was a response to long hair on men being a societal deviation. There is really nothing wrong with men having long hair, but it was against the fashion norms at the time and it evoked this response.

There was a time when race-mixed couples were afraid to go into public because of the hostile looks and remarks that they would receive. This was a normal, healthy societal response to what was different and wrong. This isn't a bad thing, but rather necessary to preserving a society.

Now, we see when this social glue is removed, the divorce rate goes through the roof, child and spousal abuse, and even drug abuse, become common. Sick sexual predators and serial killers have become so commonplace that they have actually lost their shock value. So many people are just plain oddballs these days.

The normal standards of behavior have been removed and the only thing that the Jews added in their place, the one universal trait that we all our supposed to feel and act upon, is a hatred towards White people who love the White race. And though you and I can see this hypocrisy, it seems as if many of the public have fallen prey to this indoctrination and do not see the stupidity of their ways. For example, today I received a letter from a high school-aged White kid who got in trouble with a

White teacher for wearing a "White Pride" t-shirt to his school. His immediate defense was, "Why is this wrong? The Mexicans wear their Brown Pride shirts." The teacher knew this, because her response was, "That isn't the same, your shirt is offensive and in poor taste."

Think about that. Is this teacher just a lemming, or has the Jew media brainwashed society to teach and maintain their anti-White message, without even consciously realizing they are doing it? Well, the answer is -- both are correct. She is a lemming and she was programmed by the Jews to act as she did and now she is trying to indoctrinate this young, proud White kid into thinking in the same way.

So, where did all the normal behavior go? It is being suppressed inside millions of White people. It is there, under the surface, but we live in a Jewrun nation and that is what happens to White people when Jews control us. But, once we regain control of our nation and our media, we can turn this around very quickly. The Jewish propaganda is unnatural; it goes against the genetic norms for White people. With a racially-oriented White government, the societal norms will be restored to bring back a healthy country. The amount of stress, loneliness, melancholy and social isolation will fade away, and this will bring happiness and calmness to so many of our people. The anger and disgust people feel when they are forced to witness vile acts in front of them, will never again happen.

And, just as a newborn colt instinctively strives to stand up, a White nation that removes the Jews from the control of the media will have the Zionist burden removed, and the White race will instinctively return to normal behavior again. I see the day when the White race will stand proud again.
