Synopsis: Request for information from Colleges or Universities that Khalid Shaikh Mohammad may have attended.

Details: Ramzi Ahmed Yousef, the FBI top ten fugitive wanted for the bombing of the World Trade Center, conspired with others to plant explosive devices aboard U.S. passenger aircraft while those aircraft were scheduled to be airborne and loaded with passengers on their way to the United States. Yousef, Wali Khan Amin Shah, and Abdul Hakim Murad were subsequently arrested, rendered to the United States, and convicted in the Southern District of New York. As a result of the investigation, an indictment was obtained against Khalid Skaikh Mohammad in connection with the same conspiracy. The United States Department of State has posted an award for information leading to Khalid's apprehension.

It has been known that Khalid Sheikh Mohammed attended college in the United States. Attempts to locate Khalid's INS entry into the United States, as well as the University he attended, have not been successful until recently. It was just recently learned that Khaled Skaikh may have attended Chowan College in North Carolina beginning in the fall of 1984, studying

The Charlotte Division confirmed that Khalid Shaikh attended Chowan College. The Charlotte Division has reported that Khalid Sheikh used the name Khaled Al-Shaikh Mohammad, DOB 4/24/1965. He listed his fathers name as Zahed Mohammad, and his high school as the Al-Fahaheel Secondary School, Fahaheel, Kuwait. The passport provided was AK 488555. The passport may be Pakistani or Kuwaiti, but he is a Pakistani citizen. Charlotte reported that there are no records of Haji Adam at Chowan College.

It was also reported that Khaled had transcripts sent to a number of additional universities after his semester at Chowan College.

As recipients are aware, Khalid Shaikh Mohammad has been linked to the attacks on the World Trade Center and Pentagon on 9/11/2001.
